

# News from the Executive Council...

#### LPA Members Speak at Psychology Board; Board to Reconsider CE Rule Revisions

Several Council members of the Council attended the long-range planning meeting of the state psychology board held on November 30 at the board's new office in Baton Rouge and expressed concerns about the proposed changes to the continuing education rule. LPA had taken the position that the board's authority was over the continuing education requirements and that the current requirements, and in particular the list of approved sponsors in the present rule, was appropriate. The public attendees were allowed three minutes each for comments and Julie Nelson, Kim VanGeffen, Tom Hannie, Marc Zimmermann, and Lucinda DeGrange spoke. After feedback from LPA representatives, the board decided that the proposed rule was probably confusing and agreed to review and revisit the matter.

#### **Executive Council to Meet January 19th; Continues Work On Organizational Goals**

The Executive Council will hold its quarterly meeting on January 19 at Kim VanGeffen's home in New Orleans. The Council will distribute reports and then continue working or organizational development goals, primarily planning for membership development, improving website, addressing social media resources, and reviewing convention plans. #### **Committee for Colleague Assistance Created**

The President has appointed Dr. Kelley Pears to head up the new special committee for colleague personal and professional assistance. The committee also offers ethical and professional guidance, with committee member Dr. Tom Hannie offering guidance about professional and ethical questions. Dr. William Costelloe will help members with career questions and Dr. Beth Caillouet Arredondo will assist Early Career Psychologists with their career questions. Dr. Hannie has already answered two questions about professional and ethical matters for members. Dr. Kelley Pears is working on the committee structure and methods and will report soon to members about his progress.

#### Rural Health Has "a long way to go," Says Dr. Jennings

The Louisiana Department of Health announced September 24, 2018 that it had received a Federal grant of more than \$24 million toward addressing the opioid epidemic in our state, said Dr. Tiffany Jennings, licensed psychologist in Shreveport, and Louisiana Psychological Association Rural Health Coordinator for the American Psychological Association, who chairs the Rural and TeleHealth Services Committee for LPA. "This grant was funded from the Center for Disease Control and Prevention and the US Dept. of Health and Human Services," said Dr. Jennings. "The money will be used for improving access to treatment, prevention strategies, improving surveillance data and to enable health centers and other agencies to expand integrated services treatment." This is a step in the right direction. "But we've still got a long way to way," said Jennings.

#### **Professional Affairs, Reports on New CPT Codes**

As of January 1, 2019, the new CPT codes for psychological and neuropsychological testing are in effect. These new CPT codes create a significant change in the way in which insurance companies will reimburse testing services. In the past, one code was used to bill test administration and scoring whereas the new system separates test administration/scoring from test interpretation and report writing. The new testing codes represent a significant change in that psychologists will now be able to bill for the time which is spent in activities such as planning assessments, test selection, interpretation and integration of test data, report writing and treatment planning. #### I-O and Consulting Psychology Committee Meet with Area Professionals

Members of the Industrial-Organization and Consulting Psychology Committee, chaired by Gig Costelloe, will be meeting with other professionals and human resource management individuals at the French Truck Coffee Café on Government Street in Baton Rouge on January 12. Courtland Chaney said that the group will likely discuss plans for a consulting psychology track at the 2019 LPA conference. Courtland said, "The 2019 I-O track will be conceptualized as a Consulting Psychology track and will encourage presentations covering a broad application of behavioral science knowledge, including assessments and interventions at individual, group, organizational and community levels of human systems. Because consulting psychology concerns applying and extending behavioral science knowledge through the process of consultation to problems involving human behavior in various areas, we concluded a consulting psychology track would have a broader appeal across behavioral science specialties."

#### **Conventions & Education Committee, 2019 Convention**

Planning for the 2019 Annual Convention is proceeding well according to chair Julie Nelson. "We have settled on a good contract with the Sheraton Galleria and discussed with them some improvements that we feel will make the event even better this last year. We just recently received confirmation that Dr. Tony Puente, Past President of APA, will be a keynote speaker. He is known for his vision for the future of practicing psychologists and will strongly contribute to our theme, 'Psychology: Making a Difference." Dr. VanGeffen said, "He is a great speaker and I think that people will want to hear him given that he is on the forefront of so many of the changes taking place in mental health care."

Nelson said, "Our committee is having a planning meeting next week and we'll connect with the chairs of the interest area committees to find out their best and most important topics, to help us flesh out the training program. I imagine that we will have an extremely interesting research poster session—we always do—and we are also working to connect with our colleagues at the various universities for the Science Café again this year. Perhaps the most surprising but consistently high rated event we have provided is the collegial Lunch & Learn training. We'll be including some interesting variations and making it better again this year."

#### School Psychology Committee Member Activities

Advisory Council on Student Behavior & Discipline—LPA is a member of the ACSBD by act of the LA Legislature. In the first year of ASCBD's work, LPA's member of the Council made a formal presentation on Positive Behavior Intervention and Support (PBIS) for council members and the public. LPA, with other groups, has supported the continuing need for training in evidence-based practices such as PBIS and the need for more personnel trained to provide mental health interventions. Annual reports have been filed for 2016 and 2017. Louisiana Legislature Bullying Awareness and Intervention Task Force—LPA, the Louisiana Chapter of the National Association of Social Workers, and the Louisiana Association of Marriage and Family Counselors are founding members of the legislature's task force on bullying awareness and prevention. LPA has emphasized the need for increased efforts in prevention and led the review of research in this area. An annual report was filed for 2017 and the report for 2018 will be available soon. The task force will conclude this year after considering additional testimony, reviewing current practices, and making recommendations for needed changes.
